## Personal Donations

Thrivent, in partnership with InFaith Community Foundation, helps clients and others make online donations to enrolled organizations. Thrivent will cover all the online processing fees, so 100% of your donation goes to the organization.\*

## Choice Dollars®

By directing Choice Dollars, eligible clients can recommend where some of Thrivent's charitable outreach funds go.

Eligible clients are designated Choice Dollars based on:

- The amount they pay in annual premiums for qualifying products—life, disability income and long-term care insurance.
- The total contract value of their qualifying products—annuities and life insurance.
